**Soventol® Stift**



### **Composition**

Denatured alcohol, menthol, dexpanthenol, Aloe barbadensis, polidocanol, xanthan gum, purified water, citric acid, disodium phosphate dodecahydrate.

1 pack contains 4 ml gel

### **Intended use**

Soventol® Stift has a cooling effect that can be used for localised relief of itching and burning, for example, insect bites and sunburn.

### **Contraindications**

#### **When should you not use Soventol® Stift ?**

Do not use Soventol® Stift :

- if you are allergic to any of the ingredients
- on broken skin or wounds

### **Warnings and precautions for use**

#### **What precautions should be taken?**

Do not use Soventol® Stift on children to treat large areas.

Soventol® Stift should not be used on the face or neck in children under 2 years of age.

Do not use in or around the eyes.

Difficulty breathing may occur in the event of accidental swallowing of the lid. Seek medical advice straight away if this happens.

## **Interactions**

### **What other medical devices or medicines affect the action of Soventol<sup>®</sup> Stift or can be affected by simultaneous use?**

Please note that this information may also apply to medicines or other medical devices that have been used recently.

The release of active substances from other skin products and their absorption by the skin may be increased by Soventol<sup>®</sup> Stift . Therefore, Soventol<sup>®</sup> Stift should not be used together with other skin products on the same area of skin.

## **Dosage instructions, method and duration of administration**

### **How and how often should you use Soventol<sup>®</sup> Stift ?**

Soventol<sup>®</sup> Stift is applied selectively to the affected areas of skin. Its cooling effect rapidly relieves the itching. Once the cooling effect subsides, application can be repeated in the same way several times a day. At the same time, the special formulation of high-quality ingredients, such as aloe vera and panthenol, soothes and looks after the irritated and itchy skin with lasting effect.

## **Side effects**

### **What side effects can occur with the use of Soventol<sup>®</sup> Stift ?**

If you get any side effects, contact your pharmacist or the manufacturer. This also includes any side effects not listed in these instructions for use.

Soventol<sup>®</sup> Stift is generally well tolerated. In rare cases, skin reactions may occur in the event of relevant hypersensitivity.

## **Notes and information on shelf life of the medical device**

**Soventol<sup>®</sup> Stift should be kept out of reach of children.**

**Please make sure that the pen is properly closed after use to prevent it from drying out.**

The expiry date is printed on the pen and on the carton.

Do not use Soventol<sup>®</sup> Stift after this expiry date.

Soventol<sup>®</sup> Stift can be kept for 6 months after opening.
